Safety Directions

May be harmful if swallowed.
Wash hands and exposed skin before meals and after use. Repeated exposure may cause skin allergy. Avoid skin contact. Triclabendazole may possibly affect the liver. Handle with care.

First Aid

If swallowed DO NOT induce vomiting. For advice contact the National Poisons Centre 0800 POISON (0800 764766) or a doctor immediately. If skin or hair contact occurs remove contaminated clothing and flush skin and hair with running water.

Environmental Protection

Harmful to terrestrial vertebrates. Avoid release to the environment.

Emergency Response

In case of spillage wear appropriate protective clothing and prevent material from entering waterways. Absorb spills with inert material and place in waste containers. Wash the area with water and absorb with further inert material. Dispose of waste safely.

Disposal

Preferably dispose of the product by use. Otherwise dispose of product and packaging at an approved landfill or other approved facility. Triple rinse container with water. Crush or puncture and bury in a suitable landfill. DO NOT use container for any other purpose.

FASINEX 24 can be given safely to all cattle including pregnant, young and stressed stock.

DRENCHING PROGRAMME

Immature liver fluke cause extensive damage when migrating through the liver tissue. Because FASINEX 24 is highly effective against immature as well as mature liver fluke, it should be given early in the season to reduce liver damage and prevent build up in the fluke population. Treatment should be repeated at 8 week intervals as necessary. Dairy cows should be treated only during the dry period, prior to calving. Correct drenching technique should be used.

WITHHOLDING PERIODS

1. MEAT:

Animals producing meat and offal for human consumption must not be slaughtered within 28 days of treatment.

2. MILK:

Milk intended for sale for human consumption must be discarded for 35 days following treatment. NOT to be used in cows within 28 days of calving.

EFFICACY SPECTRUM

FASINEX 24 is a ready to use aqueous suspension of triclabendazole which is highly effective against early immature, immature and mature stages of liver fluke (*Fasciola hepatica*) in cattle.

DIRECTIONS

FASINEX 24 given as an oral drench and is suited for most types of automatic drenching gun.

1. SHAKE WELL BEFORE USE.

2. Give full dose orally according to dosing schedule.

3. A representative sample of animals should be weighed before treatment.

4. Dose the herd to the heaviest animal by liveweight in each group. DO NOT underdose.

5. Where there is a large variation in size within the group, dose rate should be based on the label directions for each weight range. Drafting into two or more lines may be appropriate, to avoid excessive overdosing.

By law the user must take due care, obtaining expert advice when necessary, to avoid unnecessary pain and distress when using this product other than as directed on the label.

STORAGE

Store in a cool, dry place out of direct sunlight, avoiding temperatures below 0° and above 35°C.
